OUR COLLECTIVE MISSION:

As a grassroots-founded organization, Michigan Association of Conservation Districts is first and foremost comprised by our members. You are the driving force behind the work we do in strengthening Michigan's Conservation Districts. Many years ago, the Michigan CD community came together and recognized a need for a statewide association to represent our collective interests in Lansing and Washington, D.C. alongside the *National Association of Conservation Districts*. Collectively as an association, our voice is louder and stronger than it is on our own. As your state association, we meet on a regular basis with critical state leaders ranging from the Governor and her staff, MDARD Director Tim Boring and other MDARD Staff, USDA-NRCS State Conservationist Garry Lee, MDNR Staff, EGLE Staff, and State and Federal Legislators.

MACD is at the table for critical conversations that ultimately determine the level of financial or business support your District receives from the State, as well as how programs are structured to better meet your needs. Your membership is *critical* to supporting this overall effort. By increasing

your membership level, our Executive Director, Dan Moilanen, hopes to expand our legislative program to include additional programming, messaging, and other activities -- like our annual Capitol Day -- that will help us collectively deliver our message to Lansing. With your support, we can ensure that State leaders hear our collective voice and fully understand that CDs are *essential* infrastructure for addressing today's pressing environmental and natural resource concerns.


STATE COUNCIL

The MACD State Council, the governing board of our Association, has overall responsibility for the organization. Made up of member-elected officers and regional representatives, the State Council provides fiscal oversight and planning to assure that our Association provides members with quality programs and services to its members.

We encourage all Conservation District Directors to interact with your region's State Council Members, as they can take any issues, concerns, or ideas to the rest of MACD's leadership team accordingly.


Bronze // \$400 - \$699

MACD Legislative Advocacy / Representation Campaign

Arguably the most important benefit offered via your membership, MACD advocates on your behalf with legislators, State and Federal agencies, partners and advocacy groups. We represent your interests and advocate for you, your programs, and your natural resource conservation issues, providing a strong presence to build partnerships and understanding that grows into opportunity and programs for Conservation Districts. **With your assistance, MACD successfully secured \$3 million in State Operational Funding for Fiscal Years 2022, 2023 and 2024, totaling \$9 million; resulting in \$40,000 per district each year, for a total of \$120,000.**

The MACD Executive Council, with our registered lobbyist and support by the Legislative Committee and Workgroup, leads legislative advocacy activities that include direct legislative communication with legislators and the administration, in addition to legislative committee engagement and testimony to promote the role and purpose of Michigan Conservation Districts.

In addition, MACD holds an annual Capitol Day in Lansing, where our members are strongly encouraged to attend and meet with their District's legislators. Moreover, MACD drafts policy advocacy documents and materials to aid MACD members in our collective advocacy efforts.

MACD 501(c)3 Grant Umbrella

Platinum and Gold Level Members are eligible to utilize the MACD 501(c)3 status for grants that require non-profit status. Pre-authorization is necessary, with customized support and authorization for the 501(c)3 grant umbrella. Districts have been very successful in obtaining grants and donations from community, corporate and national foundations through this membership service.

MACD Business Insurance Program

MACD and program partner Fischer Insurance Agency have provided a comprehensive, customizable insurance program for member Conservation Districts since 1998. The Business Insurance Program offers:

- Complete insurance coverage at competitive rates (20-30% savings)
- Insurance that accommodates the unique activities specific to Conservation Districts
- A program that supports the work of Conservation Districts
- Available to Platinum, Gold, Silver, and Bronze Level Members

MACD Events and Member Discounts

Several quality educational and networking events are provided throughout the year, including the Summer Conference, Fall Convention, District Manager Retreat, and Director Workshops. These events provide a chance to learn best practices, gather new ideas, develop skills, and connect with fellow board and staff members from across the state. Region Meetings are also held to provide Districts with the opportunity to come together locally to network and discuss issues of importance.

MACD Outreach Program

The MACD Outreach Program shares the work of Michigan Conservation Districts through social media and statewide media organizations. The MACD Facebook, Instagram, Twitter/X, and LinkedIn accounts regularly post information about Conservation Districts, and CDs' many fantastic benefits, events and programs. Articles that highlight Conservation Districts and their programs are posted to the MACD Blog and shared through news media outlets and conservation-related media sources, including Michigan Farmer, Michigan Outdoors, and Woods-N-Water News. Annually, MACD promotes Stewardship Week in April by collecting and producing materials and marketing for our members. In addition, MACD works with the Governor's office for an official proclamation on "Conservation District Day" on July 17th.

Branding is essential for building recognition of Conservation Districts' incredible work throughout Michigan. MACD provides a logo and marketing tools that are customizable to your District, to help build recognition for your CD's work locally, while also maintaining a common brand for Michigan Conservation Districts statewide.



2024 AND BEYOND: LOOKING AHEAD

As MACD's Executive Director Dan Moilanen enters his third year working for the Association, he has his eyes set on keeping MACD within the "Growth Mindset." Dan's vision for the future of MACD involves hiring a Development Director to help further grow revenue streams for our Association. Historically, MACD has underutilized our "Partner Memberships," which we hope to expand with the help of a full-time Development Director dedicated to building strategic partnerships, securing sponsors for MACD events, Envirothon, and more. If your District typically only renews your membership at the Bronze level, we strongly encourage you to consider increasing your dues this year. If MACD is able to raise an additional \$40,000 through membership dues -- a total of 30 CDs increasing their membership to the Platinum level -- we will be able to hire a Development Director. This staff member would then essentially pay for their position by increasing MACD's revenue streams and sponsorships. With additional resources, MACD could also expand our programming to further support our mission of strengthening Michigan's Conservation Districts.



What would that look like? MACD providing expanded services to our membership like Human Resources, Accounting, and other expanded business support programming.

With additional development funds, MACD could also expand our lobbying team to include a full-time MACD Staff Member dedicated to tracking legislative bills, developing white-papers, and continually building relationships with legislators.

Lastly, we're working hard to bring Envirothon back to Michigan. Increased funding for this critical program will be essential. Your CD's additional support will help us improve Envirothon's funding structure to ensure today and tomorrow's high school students are introduced and recruited into careers in Conservation.

By increasing your CD's support, MACD will be stronger than ever, ready and running to help Michigan's Conservation Districts take on whatever challenges 2024 (and beyond) throws at us. We can do this, together. We thank you for your consideration and continued membership.




